

GOVERNMENT IS A CORPORATION

One of the most obvious yet vastly not realised facts within the system is that "government" is nothing more than a corporation, meaning it is just a dead entity that exists on paper only.

Note: Corporation means it does not exist in reality and therefore has no rights.

Corporation

The word "corporation" is a combination of a Latin word "Corpus" and a late middle English word "oration" meaning "formal speech" especially one given on ceremonial occasion.

The origin of the word *oration* came from the *Latin* word "orare" meaning to "speak" or "pray", which became "oratio" meaning "discourse", "prayer".

A *corporation* is a *legal entity* that is formed by an association of people usually to be run as a business.

However, there are different *types* of *corporations*, and being a *corporation* does not necessarily mean it is a business, although in almost all cases the reason for setting up a corporation is to gain *wealth* and *power*.

For a corporation to gain power, whatever type it maybe, requires people to become both *believers* and *followers* of said corporation.

These *followers* give up their responsibility and sovereignty to a *fictitious entity*, in the belief of a better life, but by doing so will unknowingly live a life of poverty and servitude for a hidden master.

Within politics when the phrase "power vacuum" or "power grab" is used they are referring to the gathering of lost souls who have given up their rights, freedom and sovereignty and have become irresponsible people without name or status, and are now nothing more than chattel.

Note: to believe in a *corporation* requires the followers to be under *mind control*.

The idea of setting up a *fictitious dead entity* or *deity* to hide behind while conducting unlawful actions is not a new one, and dates back thousands of years, with perhaps the first being a *religious corporation*.

Religious Corporation

One of the earliest forms of a *corporate entity* was through the creation of a *religion*, often by using a deity or God, which is controlled by those who founded the religion.

Once enough lost souls had given up their independence, freedom and dominion, they are instructed to given "penance" or face punishment by the very god the lost souls had chosen to believe in.

Note: To give *penance* means to pay "the church" or face punishment for your sins.

The many atrocities "clergymen" would conduct in the name of a corporation, such as a "god" or simply just "the church" are well documented throughout history.

The Spanish Inquisition or *The Tribunal of the Holy Office*, both corporations, was established in 1478 by the *Catholic Church*, and was disbanded in 1834.

Interrogators, which is a *legal title*, would conduct many forms of torture, such as "the rack", "the pulley" and waterboarding, onto followers under the name of "the church".

Individuals using *legal titles* such as *"inquisitor General"*, *"Receiver"* and *"commissioners"* would hide behind the *legal fiction* or *corporation* of *"the church"* to torture and even put to death people, with burning at the stake being a common undertaking.

Crown Corporation

The word "crown" refers to an ornamental headdress, often made with precious metals and jewels, which is worn by a monarch as a symbol of authority through the title of sovereign.

The earliest recorded history of the first use of a "crown" was in 2485 to 2472 b.c.e when **Sahure** of ancient Egypt was the first king to wear the **Atef Crown**.

It appears the first use of the word "crown" is from the Old English period, pre-1150 AD and was taken from the Latin word corona and meant "regal power".

Pheasants subjugated by the king where often persecuted by agents of the king but under the *legal fiction* of "the crown" or "in the name of the crown", in a vain attempt to distance the king from the unlawful actions of said agents.

Within the *Kingdom of England*, in the early 10th century, the concept of *"the crown"* being a *corporation* developed, further attempting to separate the *physical crown* and property of the king from the *corporation "kingdom of England"* or just simply called *"the crown"*.

Although, the term "the crown" is almost impossible to accurately define today by scholars and academics, "The Crown Corporation" is the largest global corporation within the world and owns every title that is currently registered.

<u>Note:</u> To gain "Crown copyright" means to register with said corporation and hand over the equitable and controlling interest to the item being copyrighted.

Crown law

"Crown law" refers to the office of the monarch or monarchy institutions, such as "the crown-in-council", "the crown-in-parliament" and "the crown on the bench" referring to governance and the civil service.

This crown law jurisdiction also includes a *crown controlled common law* that applies to peasants and commoners, but *not* those of royal or regal stock.

However, when you question where the *authority* of such a jurisdiction comes from then the deception is very evident to see.

It all stems from the "original king", who claimed title of sovereign, but when you question the source of such sovereignty it is claimed that it comes from "The People" living upon the land.

However, the term "The People" is abstract and therefore meaningless.

There is no signed contract between the individual people and a king allowing their **sovereign status** to be controlled by the **sovereign title** of the king.

Political Corporation

The origin of the word *political* comes directly from the *Latin* word "politicus" which means "of citizens" or "the state", and over time politics has become to mean the administration of the state towards those who are citizens or members of the public.

For the deception of this ruse to work, the people must accept the charade of orchestrated politics and vapid baseless debates, and take the position of "member of the public".

Opposing political parties, all claiming to speak for their own form of *corporate government*, argue over topics that actually have no real relevance, with many not even existing.

This form of *Hegelian dialectic* is designed to cause *division* between people, making them willing to take sides on a non-argument.

<u>Note:</u> Hegelian dialectic means to find a contradiction within a proposition, and create a *thesis* and an *antithesis*, or opposing sides to the proposed topic.

In layman's terms, are you for or against something? There is no middle ground.

Politicians will claim they will help those who follow *their* point of view, and all they have to do is become believers of the *politician's corporation* called *government*.

People pick a colour, be it red or blue it does not matter, they have already lost.

It is irrelevant what party the politicians claim to work for, ultimately it all ends in following the *same government*, and once again mankind is *trapped in a box*, with the cycle of misery continuing for generations.

This form of *political corporation* has caused countless wars, with most people fighting not even knowing why they are willing to kill or be killed.

The word "govern" from Middle English has its origin in the Greek word "kuberman" meaning "to steer" or "to control".

"Mentis" means "mind" in Latin, with "ment" meaning "lie"; "Govern-ment": To control the mind through lies, or lie to the mind.

Note: Never accept the sales pitch, as in most cases it is a lie.

Business Corporation

When the word *corporation* is used, most people think of large businesses or companies, which is perhaps the largest form of corporation today.

A modern day *business corporation* is a *legal entity* that is separated from its owners, and is authorised by *"the state"* to act as one *person*, and has *"rights and liabilities"* within corporate contract that are separate from the individuals who formed it.

It is set up by a group of people, who usually but not always, wish to stay anonymous, and through registration becomes an *incorporated* entity authorised by *"the state"*, which in itself is a corporation, to conduct commerce within *"the states"* jurisdiction.

<u>Note:</u> *Incorporated* means the process by which a new or existing business registers with Companies House usually as a limited company.

Once *incorporation* is completed the *new corporation* is issued with a *company house number* and *DUNS number*, with a *certificate* detailing those who set up the corporation.

Note: You have the right to request this certificate when dealing with any corporation.

The *corporation* is now a recognised *legal fiction* within "the states" jurisdiction of *commerce* and as such is now bound by national and sometimes international *corporate policy* which is often inaccurately referred to as *law*.

<u>Note:</u> Early *incorporated entities* were established by charter, meaning being granted by a monarch or passed by a parliament. However, almost all *incorporated businesses* are now created through *corporate business registration*.

<u>Note:</u> To be able to deal or make *contract* with *any* corporation, you must have use of your own corporation, which unbeknown by most is the modern day *birth certificate*.

Court Corporation

Although, all courts today are nothing more than *business corporations*, the very phrase "The Court" is a *corporation*, because if you do not know *whose court* it is, then it does *not* exist.

To understand the deception, you must first realise that only a living man or woman exercising their *status* as *sovereign* can hold a court, as it would be *their* court.

Further to this and for a *court* to exist there must be someone who is, not only making a *claim* against another *sovereign*, but will also stand by said claim as the court which is held is done so through *their name*.

Therefore, if you have been "summoned to court" the first question should be whose court, and the next would be under what authority?

However, as so many people have either forgotten this or cannot make the cognitive realisation to comprehend that they should know the answers to these questions, they fall foul of a *corporate court* used for nefarious financial gain, by those who hide behind it.

There are many different forms of *corporate courts* operating within the *legal jurisdiction* called *"the world"* and as such can only operate at an *administrative* level, which in itself is proof that *no law* is being conducted, but only *policy*.

The people who run their *private for profit corporate courts*, and there can be no debate that they are indeed privately run, do tell the general public this, but as most are illiterate they do not understand.

As an example, we shall use the **UK corporation** court system detailed below:

UK Corporate Court System

There are currently approximately 170 county courts in England and Wales, each with its own separate *corporate legal identity*, operating within a defined geographical area.

Tribunals

At the lowest level within this *corporate structure* are *Tribunals*, which cover certain jurisdictions within *"civil law"* usually where employment is concerned.

County Courts

Operating at the next level, along with *Magistrate courts*, within this *corporate structure* are *County Courts*, which deal with civil claims such as debt recovery, contract disputes, and personal injury claims.

The official narrative also states that these courts also handle "minor criminal cases", such as "traffic offenses" and "minor assaults".

Note: The term "traffic offenses" refers to an "offense of breaching policy within contract".

However, the *County Court* can also hear appeals from *Magistrates' Court*, in both civil and *"criminal cases"*.

Note: It should also be noted that all cases are heard by a County Court judge, **without a jury**, meaning it is **administrative**, operating within a **corporate jurisdiction**, and <u>not</u> a court of law.

The maximum number allowed within this administrative court is 7, so a jury *cannot* be formed to take over jurisdiction of the court.

Magistrates' Courts

All "criminal cases" will start in the Magistrates' Court, but more serious criminal matters are sent to the Crown Court.

These Courts deal with "minor criminal cases", as mentioned before, and they also handle some "civil cases", such as debt recovery and landlord-tenant disputes.

However, it is impossible for an *administrative court* referring to *policy* to conduct any form of *criminal case*.

In fact, they do <u>not</u> follow law, and make a subtle change from:

"You broke the law by murdering a sovereign."

To

"You did not have the correct paperwork filled out and were not granted permission by the state to carry out a murder, so you have been found guilty or breaching policy within corporate contract."

Meaning you had no "licence to kill".

<u>Note:</u> There is *no jury* within this court, as it is under the control of the *magistrate*, hence the name; "*Magistrates court*".

Crown Courts

The *Crown Courts* handle serious "*criminal cases*", such as murder, rape, and robbery, and also hear appeals from the Magistrates' Courts.

<u>Note:</u> The name "Crown" used to refer to the king or monarch, but now refers to the "crown corporation".

There should be a jury of 12 present; however, this is a "jury trial" and not a "trial by jury", meaning the Judge "controls the law", or more accurately corporate policy, and not the jury.

It is impossible for any Jury to remove *law*, but it can remove *policy* from a *contract*.

High Court

The next level up is referred to as "The High Court" and deals with more complex civil claims and serious "criminal cases".

There are three divisions of the High Court:

- 1. the King's Bench Division
- 2. the Chancery Division
- 3. the Family Division

Note: "family" is now a legal title referring to the lowest unit within a community or society, with "Parent" and "child" also becoming legal titles.

Court of Appeal

The *Court of Appeal* is the second highest court within the jurisdiction of the *UK Corporation*, above *High Court*, and hears appeals from the High Court and other lower courts.

<u>Note:</u> To *appeal* means to beg and accept the *obligation* of the charge made against you, therefore you have already lost.

These corporate courts are under the control of three judges, **without** a jury, and administrate the policies of the contract operating within this jurisdiction.

Like all these courts, it does not deal with any living sovereign, but only *legal titles*, including *"your" legal persona*.

Note: There are no appeals in a true court of law held by a sovereign in their name.

Supreme Court

The final court of appeal is *The Supreme Court*, which is the highest court in the *UK Corporation structure* and deals with appeals from the *Court of Appeal* and other lower courts.

This court also acts as "the final court of appeal" for some cases from England, Wales, Scotland and Northern Ireland, which are all corporations also.

<u>Note:</u> There is no jury within this court, just a panel of twelve Judges.

This court is the final arbiter between the *citizen* and the *state*, with the ultimate decision remaining with *Parliament* and *not* the *judiciary system*, meaning those who fall prey to this jurisdiction are now *slaves* to a corporation called *The United kingdom*.

Summary

Just like the *UK Corporation*, all these courts are registered with *Companies House* and have a DUNS number for credit reporting, just like any *for profit corporate business*.

Country Corporation

When an institution, company, organization or *country* is *"founded"* it means to *"set up"* or to *"get started"* by a group of people.

These people will set up the *foundation* for their *corporate entity*, hence the term *"to found"* or *"founded"*.

<u>For example:</u> when seven men set foot on a new land, they created the **corporation** called **"the United States"**, and became the **"founding fathers"** of a **nation**.

They were George Washington, Thomas Jefferson, John Adams, Benjamin Franklin, Alexander Hamilton, John Jay and James Madison.

Note: The *land* was there *before* the *country* was *founded*, and will remain long after the *country* has collapsed.

There are subtle differences between a *nation* and a *country*, although they are both *corporations*.

<u>Note:</u> There are 193 *national* flags within the corporation called the United Nations, and 287 world flags.

None of them are yours.

Nation

In general, the word *Nation* applies to a large group of people with a unified language, similar or compatible characteristics, shared customs and cultures; a group of cooperating people living in peace, with a history and heritage.

The origin of the word *nation* is from the *Latin* word "nationem" meaning "birth, origin, breed, stock, kind, species, race of people, tribe," and literally "that which has been born".

<u>Note:</u> When a government uses the word *nation*, they are actually refereeing to the *"colour of the people"* namely their individual *corporate birth certificate*, and <u>not</u> the people themselves.

Governments can control the *birth certificate*, *citizens*, *civilians*, *legal persona*s but not the *living* man or woman born upon the land.

Country

A *country* is a *corporate jurisdiction* that is placed upon a geographic region, creating boundaries and borders for those operating in said jurisdiction.

Said *corporate country* will have its own internal government, administrating internal corporate policy that does <u>not</u> apply to the physical land, but is just a jurisdiction placed upon it.

Furthermore, they require a *President* or *Prime minister* to administer the various agencies or departments within the *corporation*, such as department for transport, department for business and trade, department for work and pensions, and so on.

To be *subject* to the *jurisdiction* of any *country* requires an accepted *legal title* through *contract*, making you an "*employee*" of the corporation, and therefore subject to its policy.

Once the *corporation* is set up to cover a *geographic location*, entry into this *jurisdiction* must be *voluntary* as a corporate jurisdiction *cannot* be applied to people already using the land.

One person or even a group of people *cannot* claim land that is currently being used by all, including the roads.

<u>Note:</u> No claim or forced corporate jurisdiction can ever be made upon roads, as this would violate the rights of those who wish to travel.

All *corporate road restrictions*, such as bus lanes, speed humps, cycle paths and pedestrian zones are all unlawful and illegal.

We all share these roads equally, with any claim being made upon them to be dealt with harshly.

<u>Note:</u> To claim a parcel of land for yourself you would **stake** out the land, give notice to people in the area of your intentions, and if no one objects, you **"stake your claim"** through affidavit.

Only the *living* can make claim to land, a country *cannot* do this, so the people who control the *country* create a *corporate jurisdiction*, that you are tricked into accepting.

Here is a list of countries that either no longer exist or are no longer recognised.

<u>Note:</u> Due to political opinions and academic disagreement, the dates given are an approximate guide to be used only to prove the point that countries come and go.

- 1. Abyssinia 1270 until 1974
- 2. Austria-Hungary 1814 until 1918
- 3. Bengal 1338 until 1539
- 4. Corsica 1296 until 1768
- 5. Burma 1948 until 1989

How can physical land just simply disappear or be declared not recognised? Of course it cannot, but a *legal fiction corporation* can.

The land was there long before any country was founded, and shall remain long after the county ends.

Summary

Within the heart of man lives the fear of "the beast"; however, "the beast" does not exist, just the belief in it does.

Today the modern version of "the beast" is "the corporation", yet it does not exist.

The people who control this system of mind control enjoy ridiculing those who fall victim to it, and place hidden messages within books, music and cinema knowing most people are too dumb to see it.

The movie, "The Wizard of Oz", was released in November 1939.

Within this movie are many messages but the one main message is to see past the *fiction*, whether it be "the Beast" or "the corporation" and pull back the curtain to find the man operating the levers of mind control.

Once you can do this, you will see just how fragile this system truly is, because it does not exist.

Ask who created "government" and how, and the deception becomes obvious.

If the "The Council" is created by "government" through statute; and the "government" is also created through statute, then who created statute?

This is clearly a circular argument.

<u>Note:</u> "The people" did not create the government, as "we the people" is abstract and therefore meaningless.

Only weak minded fools would fall for this most obvious fraud; a sovereign would not.

If no living person is taking liability for creating the corporation called *government*, then therefore *without* author, and consequently *authority*, it does *not* exist.

The truth is that both "Councils" and "Governments" are corporations without ownership, and therefore worthless and without merit.

CORPORATE COURT STRUCTURE
