## **NOTICE OF CLAIM**

Re: incident that involved a Billy Bob Van, which ran over my Garden Gnome on the 8<sup>th</sup> June 2021.

I hereby give you written notice of claim regarding the damage to my property and trespass thereof, which occurred at 14.32pm on Tuesday the 8<sup>th</sup> of June.



My garden gnome of extreme rarity and of considerable value was damaged beyond repair after a van, with Billy Bob signage and displaying the registration of 1234 ABC, reversed onto my property without authorisation and ran over my gnome.

You are hereby notified of the following points:

- 1. The van, registration 1234 ABC entered my property by reversing up my private driveway and struck my gnome.
